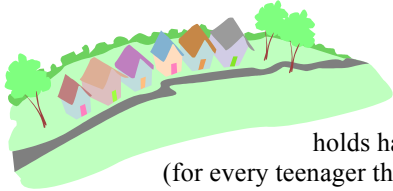
Alex Tempel is available: to pick-up vacation mail and/or newspapers, as a parent helper or short-time babysitting.
