You must call at least one day in advance to make a reservation. There will be **no same day reservations** available at this time. The board will continue to monitor usage and gather homeowner feedback to help evolve this phase or future changes.

## **Update from your Inspector of Elections**

Election ballots were sent out on June 13th, 2020 via the United States Postal Service (USPS). A quorum of greater than 25% is required for the election to be deemed valid, so if you haven't already sent in your ballot please do so as follows:

- Send in your ballot via the United States Postal Service by July 16, 2020
  - OR
- Hand deliver your ballot to the Inspector of Elections at Shadow Brooks Swim Club on July 19th,
  2020 from 6:30PM to 7:30PM at the Board Meeting

The ballot counting will be broadcasted over Zoom video conferencing. Please go to Shadow Brook Swim Club website for the most up to date Zoom virtual meeting link.
