- Burkett's Pool Replastering update
 - Change order of \$2200 required to repair damage to the Gunite at both sets of stairs seemingly from a leak
 - Progress is going slower than what was hoped for due to their inconsistent attendance, but workman ship is solid
- Draught resistant landscaping & electrical trenching complete
- Electrical conduit relocation in process and going well
- Pool Re-opening March 1 (or when replastering finished) to May 27 (start of Summer Season)
- Will discuss guest fees at next meeting



- Need to replace 3 pop ups that were damaged
 - Tracy to contact Stacy and Katie to get the specifications so she can order them and have them delivered to Kevin's home
- Capital improvements budget on hold / pending

- Condo Control & online payment process update
