PRESIDENT – David Heindel

- Opened Meeting at 7:02 PM
- Secretary confirmed Board quorum of 5 of our 6 board members
- There were 6 people in attendance including Cheryl via Zoom
- President's most important tasks during the next several months
 - o Find a new attorney
 - Go door to door to neighbors not yet on Condo Control and encourage them to sign up
 - o Work with Emre and Condo Control to orchestrate the next election online
 - Work on Election rules with the new attorney
 - o AQI Index back on website
 - Engage with a new bookkeeper to take over Quick Books, HOA Dues payment tracking
 - Investigate a Property Manager to complete the time-consuming routine tasks currently being done by President, VP Pool, Secretary and Communications Condo Control administration
 - Each position to make notes of these duties to be outsourced prior to our next meeting.
 - o Investigate putting together a coupon book for \$30 for 10 forever guest coupons

Sharks Update – Meera for Staci and Katie

- Staci and Katie have requested that the board generate a Covid policy for them
 - Meera will formalize the policy currently being used by SJUSD and other sports teams
 - o Kevin will formalize a policy for the Lifeguards
- Time trials are on Saturday, and there will be 3 additional home meets
- Snack shack has been set up with Costco, Safeway, and Instacart on the Secretary's SB credit card. All receipts will go to her, so no reimbursements will be necessary
- David will provide cash for making change to Snack Shack team envelopes will be provided for earnings to be deposited so that we can track expenses and revenue.

POOL – Kevin Ryan

- Plastering project still has some minor outstanding items so we are continuing to withhold the final payment until complete.
- The cost to refill the pool was approximately \$1200



- There are problems with the chlorine equipment in both the main and the baby pool. Kevin still working on the quote for replacement
- Kevin has repaired the Water heater in bathrooms
- Still working to get security camera wires off the fence and in the trench
- Kevin will investigate how Brivo access can be de-activated once the pool is open for summer
- Clarified the pool guest policy to be a maximum of 5 guests, with payments not required for grandparents and adult children not living in the home.
 - Associate members are the immediate family living in the house and they may bring up to 5 paid guests
 - o 6 guests or more require booking a party
- Emre will update the pool guest and party policy on the website
- Swim lesson sign ups will be Saturday from 1-4
 - Emre has set up payments for swim lessons in the Condo Control Store
